The Enrolled Agent is a highest Tax qualification in US having a privilege of representing taxpayers before the Internal Revenue Service. The EA Exam is officially known as Special Enrollment Exam (SEE).



Eligibility Check

- Exam Eligibility:
 - Candidates should be at least 18 years old
 - Candidates must obtain a PTIN to sit for SEE Exams
- Certificate Eligibility:
 - Passing all 3 papers of the SEE Exam is required
 - Completing Form 23 for the licensing application.



Pattern and Scoring

- 3 Part exam - Individual Tax, Business Tax, Representation
- 100 MCQs each
- Pass Marks: 105 from a total of 130 marks
